

1.0 Scope

1.2 Preparing an PHD

Assessments are undertaken by GGT Qualified Exemplar Global Lead Auditors and subsequently accepted for Certification by the GGT Program Director (also a Qualified Exemplar Global Lead Auditor) under the Personal Products Standard v1.0/1.1, and Cleaning Products Standard v1.1/1.2 and above Program Rules.
